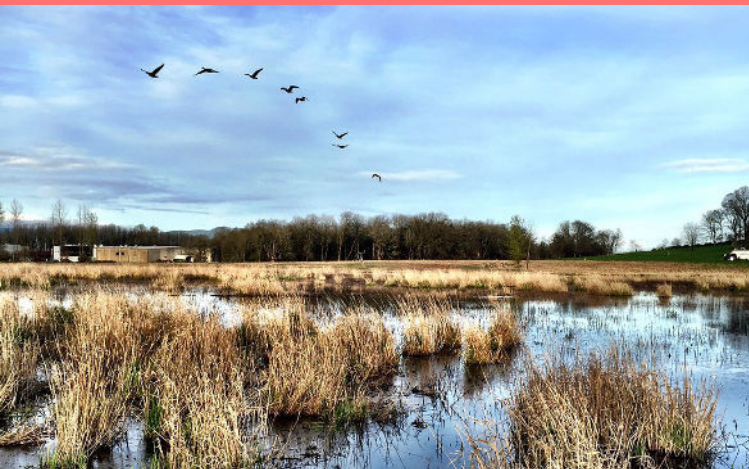

## Truth, Reckoning, and Right Relationship (TRRR) with the Great Lakes Cleveland, Ohio

CELDF has always been a truth-teller. We've also experienced how some of those truths take time to reckon with. But it's in those moments where potential lies to do something different, something more in line with what is actually needed vs. what we may be conditioned to believe is possible.

In April, we continued what we started last October at the Rock and Roll Hall of Fame, in a chorus of truths about how our culture and personal connections to the Great Lakes and nature have had serious impacts. At the [Museum of Contemporary Art Cleveland \(moCa Cleveland\)](#) we engaged with more reckoning and connections that pointed in the direction of right relationship. It was an extraordinary two days with old and new friends using a structure of grounding, exploring, connecting and moving forward all inside the frame of relating to others, both human and nonhuman.

CELDF is using the TRRR framework from these experiences to design a guidebook for communities to host their own gatherings and as a way to approach community organizing as a whole. Stay tuned for more in early 2025.

## Protecting Mother Earth Conference

### Cherokee, North Carolina

Rights of nature has made its way into 44 countries around the world. It's an extraordinary achievement considering that the practical implementation of legal rights for nature was made visible less than 20 years ago by CELDF.

CELDF's Executive Director, Kai Huschke, was provided an opportunity by the Indigenous Environmental Network (IEN) to be a champion for the potential of rights of nature and its protector as part of a four hour discussion at the [Protecting Mother Earth Conference](#). CELDF understands how Rights of Nature can be an acceleration and bridge towards more traditional ways of First Peoples to assert customary practices and for all communities the ability to self-determine.

## Peace and Justice Studies Annual Conference

### Niagara University, New York

CELDF's Consulting Director, Tish O'Dell led a 2-hour workshop entitled "What We Do to Nature, We Do to Ourselves". The location of the conference, so close to the horrific environmental disaster of Love Canal, is a living example of the title.

Participants in the workshop discussed our societal reactionary approach to protecting nature, instead of a precautionary approach, which perhaps should be expanded to include some difficult self-reflection. The Rights of Nature Movement was discussed as one possible legal approach to changing laws and policies but its greater contribution may be its effects on our thinking and opening up the possibility for conversations about our interconnectedness with nature.

# RIGHTS OF WETLANDS. COMMUNITY RESISTANCE + RESILIENCE OF THE SARAYAKU

Since helping draft the Declaration on the [Rights of Wetlands](#) in 2020, CELDF has had the honor of working with a consortium of groups from around the world, largely led by scientists, in growing both the national policy level and community practice in the frame of the inherent rights of wetlands. One way this is unfolding is through a multi-partner, multi-country, multi-year project funded by the UK's Darwin Initiative to bolster rights of wetlands from the national policy and community levels.

Through this effort, CELDF landed in the Amazon with the Sarayaku People of the Kichwa-speaking territories for a week in September. CELDF's Executive Director, Kai Huschke, and Gillian Davies, from CELDF's partner, the BSC Group, were on hand to expand the work on rights of wetlands as well as participate in a four-day conference organized by NYU's Law School's More Than Human Life Project.

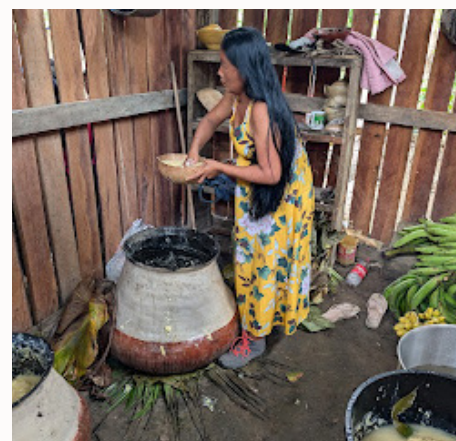
The Sarayaku call what centrally guides them Kawsak Sacha, which translates into the Living Forest.

The Sarayaku serve as an important example of not only how to feed and support a community but also the underlying value system that protects the ecosystems they are a part of. This is what CELDF has been focused on the past several years as we expand our ability to provide Community Resistance + Resilience support to communities in the United States. All of this builds on CELDF's pioneering work which began with the world's first rights of nature law, adopted with CELDF's guidance, in 2006.

# 30 years and beyond

**CELDF has been there and done that a couple of times now over the years and we are at it again, adapting and reinventing how we keep supporting community health by working to upend the system that has put communities in harm's way. Internally we've tracked our nearly 30 years of existence through phases:**

**PHASE 1** was the period of doing it like everyone else. **Fight the permit** and you'll win. Yet despite winning on paper, the corporate applicant ultimately wins since the rules are conceived by them. The house always wins.

**PHASE 2** was our efforts to change the rules to benefit human and other-than-human members of communities with local bills of rights. But despite hundreds of **CELDF-drafted community and nature's rights laws** being adopted in nearly a dozen states, prompted by a multitude of industrial

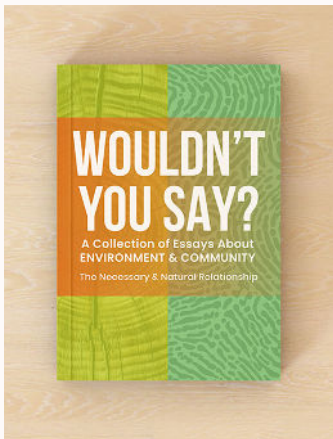
assaults, there was never an upswell to transform state and federal laws to validate the community rights sought. What did happen was increased corporate litigation, attempts to disbar or sanction CELDF attorneys, and punish communities with the threats of fines. There was also adoption of more restrictive state laws against community empowerment and the **muzzling of free speech by making citizen initiatives** more difficult to run.

**PHASE 3** is focused on building out expanded capacity and capability providing community-level resistance and resilience that goes beyond lawmaking. Communities need to address threats in real time. Since local authority to protect human rights and ecological viability is denied to affected communities, tactics including protest and direct action will be needed. So will building stronger mutual aid capabilities and the implementation of citizen assemblies, alternative media systems, local food production, and energy sourcing.

We see this happening through coordination with others. It's an inside-and-outside approach with more emphasis on what communities need to be doing outside of the system, which will also entail a shift in cultural thinking about our connection to the natural world we are part of.

**CELDF has a reputation for trailblazing, and with the stubbornness of the American legal system that predictably protects the social and political advantages of the already advantaged, we are ready to flip the script as we enter our 30th year in 2025. Through CELDF's consultation, education, and community resistance + resilience program areas, together we can best build out the needed community network and continue to be the leader and agitator we have always been for systems change and the good of the whole.**

- 1 Hard to Say; Harder to Do** CELDF's commitment to [truth, reckoning, and right relationship](#), featuring [the Great Lakes](#), was put on display in April and inspired the development of a process to help other communities connect to their own local ecosystems.
- 2 Read'em and Weep Then Get Busy** - [CELDF's \*Wouldn't You Say?\*](#) series was printed in book form this fall. A second CELDF book, [Can You Handle the Truth?](#), will be released in early 2025. Both books hit hard at our realities, the why's, and what it will take to change course.
- 3 United We Prevail** A CELDF blog [Tribal Sovereignty, White Man's Reservations, and the Need for Tribal-Municipal Solidarity To Protect Our Collective Future](#) ripped open the truths of tribes and municipalities on the legal contaminants keeping true tribal sovereignty and local self-government from happening and why, working together, that could change.
- 4 The REAL Amazon** Connecting to more than human life, supporting the inherent rights of wetlands, and a snapshot of deeper community resistance and resilience converged in the Amazon forest of Ecuador in September. CELDF has been enriched with perspectives, ideas, and potential partners.
- 5 Validation and Gratitude** Over 2024 CELDF has benefited greatly from the generosity of others including a first-time donation of \$25, a legacy gift of \$100,000, a major donor's additional gift of \$2,000, and a planned giving amount of \$82,000. We appreciate it all.
- 6 So Much Fire, So Much Wisdom** This spring CELDF launched its Partner-Advisor Committee whose members will help build out CELDF's potency and potential with Community Resistance + Resilience. The committee is full of experience, ideas, and desire to change the paradigm. Please welcome: Tzintzun Aquilar-Izzo, Lina Blount, Denzel Caldwell, Dina Gilio-Whitaker, Blake Lavia, Camila Vergara, Debra Weistar, and Max Wilbert. CELDF is lucky to know and work with these caring people.
- 7 Rights of Nature in France** In November CELDF's Tish O'Dell and Kai Huschke joined rights of nature advocates from Europe, Columbia, Ecuador, and New Zealand as part of an event hosted by The Nantes Institute for Advanced Study in France to discuss the state of rights of nature/ivers and its potential to expand further around the globe.
- 8 Doing Great work for the Great Lakes** For the last two years CELDF has been working with a coalition of advocates, organizations, and tribal members along with New York State legislature Representative Pat Burke on a [Great Lakes Bill of Rights \(GLBoR\)](#) state law. The effort is moving into its third year keeping a spotlight on the Great Lakes and the need for the law to recognize the rights of these awesome bodies of water.
- 9 The Grassroots Dirtying the Ivory Halls of Academia** Over the years CELDF has been cited in dozens of academic journals, thesis papers, and law review articles because of our status as a world leader on rights of nature. In the past year alone, CELDF has made itself available to a half dozen academic researchers including a Cambridge thesis paper entitled *Towards a More-than-Human Heritage* and a law review article entitled *The Puzzling Persistence of Nature's Rights* from Harvard.
- 10 Ohio and Oregon Water Warriors** CELDF salutes ongoing efforts in Cincinnati through the group [CROW](#) to recognize the rights of the Ohio River and longtime community rights champions [Community Rights Lane County](#) whose law-making efforts to recognize the rights of the watersheds in Lane County, Oregon have been nothing short of heroic. Both groups have worked and continue to work with CELDF in their ongoing campaigns.

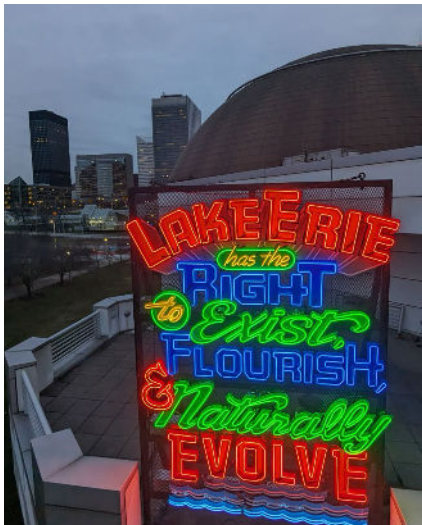

In the spring we launched CELDF's Partner-Advisor Committee. This amazing group of eight is a strong symbol of what it looks like when CELDF does ask for help. Through the guidance and partnerships with this group, CELDF is looking to develop an expansive network of ready resources for community level resistance and resilience. It means getting beyond the organizing and legal support CELDF has been traditionally known for and entering other realms of supporting communities, in a coordinated way.
